ACCEPTABLE WEATHER CONDITIONS

Air, mix and substrate temperatures should be between 40° F (4° C) and 90° F (32° C) with no rain in the forecast within 24 hours of application. For applications outside of these conditions, contact Sakrete Technical Services at 866-SAKRETE. Colder temperatures or higher humidity conditions will retard set times. Protect from freezing for 48 hours.

MIXING REQUIREMENTS

Follow water requirements precisely and use only clean, potable water. Over-watering will reduce strength, extend set time and increase likelihood of cracking. Use only clean mixing container and tools. Do not add any materials other than clean potable water or Sakrete Bonder & Fortifier.

MIXING

GENERAL PURPOSE MORTAR MIX

Use the following proportions to make a general-purpose mortar mix:

- 1 part Sakrete Portland-Limestone Cement Type IL
- 1 part lime
- · 6 parts mason sand

STRUCTURAL MORTAR MIX

Use the following proportions to make a mortar mix for structural applications:

- 1 parts Sakrete Portland-Limestone Cement Type IL
- 1/2 part lime
- 4 1/2 parts mason sand

SAND TOPPING MIX (WHERE THICKNESS IS LESS THAN 2" (51 MM) AND USED AS A WEARABLE TOPPING:

- 1 part Sakrete Portland-Limestone Cement Type IL
- 3-4 parts of concrete sand or general-purpose sand
